



The Girl Scout Gold Award: Community Support Letter Writing

What is a community support letter?

When fundraising for their Gold Awards in coordination with TFEC*, many Gold Award Girls find it beneficial to ask local organizations and business for financial support. This letter is often handdelivered to the organizations in order to ask for support. Our girls recommend wearing your Girl Scout uniform and taking a friend or parent when you go to deliver the letter. When working with TFEC, your donors will receive recognition for their donations and can use them as a charitable write-off on their taxes.

Your community support letter must be approved by TFEC prior to distribution

Dos:	Don'ts:
 Have all materials approved by TFEC. Make the letter specific to your project. Spell and grammar check. Write in complete sentences. Have an adult or friend read over your letter and provide feedback. 	 Copy and paste the example letter. Send out your letter without TFEC approval. Write only a few short sentences about your project. Provide vague details about your project and goals. Include private personal information (i.e. home address and cell phone number).
Writing your community support letter:	

- I. Introduce yourself and what Girl Scouts means to you.
- II. Explain what the Gold Award is and why it is so important. Statistics on yearly recipients and other information can be found on GSUSA's website.
- III. Explain your project in detail. Make sure to discuss how this project will benefit the community and think about why other people should care too. Talk about your personal ties to the project and why you chose it. Finally, be sure to include your goals and expected outcomes.
- IV. Request a donation. Provide a way to receive the donation working with TFEC (in the below example she uses her website).
- V. Provide contact information.
- VI. Include official disclaimer provided by TFEC.
- VII. Sign the letter.

*Any fundraising done *without* the support and guidance of TFEC may not be in compliance with IRS and PA Bureau of Corporations and Charitable Organizations, and donors will not receive recognition, such as charitable tax deductions, for their donations.
