Dear GSHPA membership,

In follow up to the Annual Meeting on April 22, I am writing to inform you of the important governance decisions that were made during our time together and advise you of how those changes impact the work of the organization moving forward.

**Bylaw Revisions:** The Council Delegates voted on several revisions to GSHPA's bylaws at the Annual Meeting. The Delegates voted to use the name Service Unit to describe the 75 consortiums of troops throughout the Council. (Previously referred to as Communities. Please allow GSHPA time to revamp all necessary materials to reflect this name change.)

Also, the term of Service Unit Delegates, Board members, Board officers and Board Development Committee members was changed to match GSHPA's fiscal year (October 1-September 30).

Finally, the composition and responsibilities of the Board Development Committee was amended to more closely align with recommended size and strategies as defined by Girl Scouts of the USA (GSUSA). The Committee will now be comprised of 5-7 members and will have the following responsibilities:

- Provide to the membership, in accordance with the time frame established by GSUSA, a single slate of delegates and alternates to the National Council Session of GSUSA.
- Develop in conjunction with the board of directors:
  - board orientation and education materials;
  - board development materials;
  - methods for identifying needed skills and talents for the board of directors and committees
  - methods for board succession planning;
  - methods for board self-assessment process
  - plan board orientation and board development training sessions as needed and/or as directed by the board of directors.

**Election of GSHPA Service Unit Delegates:** Service Units should move forward with conducting elections for Council Delegates. Delegates' terms will now reflect the fiscal year, beginning in October 2017.
