### **FOLLOW-UP TO QUESTIONS FROM AUGUST 1 WEBINAR**

#### **Do delegates and/or visitors have to pay for the Saturday night party?**

1. GIRL CELEBRATION (ages 13-20): Free for Girl Scout delegates and full passport participants in the GSLI. All of our five girl delegates fall under this category.
2. ADULT CELEBRATION (21+): This is a separate event and the charge is \$75 per person. IT IS NOT INCLUDED IN THE PASSPORT REGISTRATION. GSHPA will pay for delegates to attend; visitors will be required to pay their own way and the charge will be added to your bill. **Please let Shelly know if you want to be registered for this event ([ssprenkle@gshpa.org](mailto:ssprenkle@gshpa.org)).**

#### **What is the deadline for GSLI registration?**

1. Reserved registration in “Tier 1” closed Friday, August 5.
2. “Tier 2” of GSLI registration opens Wednesday, August 17, 1:00 p.m. EDT. Councils can still register girls until mid-September, pending availability of space.

#### **People said that there was an error in the “full passport” price on the PowerPoint. Visitors were saying that theirs should be \$245.**

1. Correct. Sorry for the mistake. The cost for Official Visitors is \$245.

#### **When does GSHPA want payment from visitors? Will we bill them?**

1. GSHPA will send one bill prior to the convention to collect the registration fees for those who need to pay them. We will send another bill after the convention for hotel costs for those who need to pay them.

#### **Housing reservations concerns. If they fly in on the 10th will they have a hotel room?**

1. See updated Hotel Room Arrangements spreadsheet to verify the nights for which we have reserved your room. Please let us know if you have any questions.

#### **We asked for delegates to e-mail their flight itineraries to Shelly so that they can be compiled on one list.**

1. Shelly will automatically receive the itinerary of anyone who booked their flight through the travel agent. Otherwise, she will be asking for your itineraries in late September.

## **What about the November 9th flight for girls and their chaperones?**

1. We need some information for the travel agent and emailed the group on Aug. 9. The flight will be booked soon. We will try to get them seated together. We do not have an “assigned” airline.

1. A survey was sent to our delegation on August 18 to determine a time for the additional webinar or conference call.
