Please remind troops: Do NOT send in the full amount collected for the Fall Product Sale, only send the amount due to Council. It may take weeks to receive a refund check of their troop proceeds.

Troops should also use the “Fall Product” Deposit Coupon when sending in the deposits, they are located in the back of the coupon book.

The Troop Deposit Deadline is December 4, 2009.

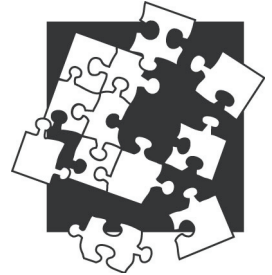
Incentives Update
