Hello Service Unit Fall Product Managers!

Have any of your troops missed an order? Forgot to add something to a girls order? A Customer loves the snowman tin and must have more? Let your troops know that they have until Friday **(November 20th – Tomorrow!) to get a Catch-up order in!** [Click here](#). We will call the troop who placed the order as soon as the orders are ready for pick-up at the designated Service Center. Please anticipate delivery being around November 30th.

Troop Handbook Correction: On page 15, the Fall Product calendar states that the catch-up order must be picked up by December 3. This is incorrect. Catch-up orders must be picked up by December 4.

Please note that girls who place catch-up orders do not receive additional recognitions, the troop however, will receive the proceeds from the product ordered.

Coupon Book Reminder

Troops should return any remaining coupon books (after all payments have been deposited for Fall Product) to the SU Fall Product Manager. These coupon books can then be destroyed. New Coupon books are being distributed to the SU Cookie Managers for the 2010 sale and they will pass them on to the troops.

December 13 – Deliver/Mail Troop sales packets to Council

Please remind troops: Do NOT send in the troop proceeds for the Fall Product Sale, only send the amount due to Council. It may take weeks to receive a refund check of their troop proceeds.

Troops should also use the “Fall Product” Deposit Coupon when sending in the deposits, they are located in the back of the coupon book.

The Troop Deposit Deadline is December 4, 2009.
